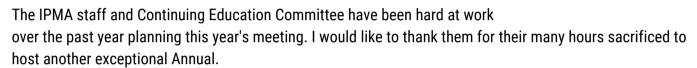


LETTER FROM THE IPMA PRESIDENT

STANDING RULES FOR THE ELECTION

ILLINOIS PODIATRIC MEDICAL ASSOCIATION ANNUAL BUSINESS MEETING

FRIDAY, OCTOBER 7, 2023 // 12:00PM - 2:00PM // HYATT PLACE CHICAGO- O'HARE, ROSEMONT, IL

- 1) These Standing Rules elaborate on the IPMA Bylaws regarding the election of officers and directors at the Associations Annual Business Meeting.
- 2) Under the Bylaws, a quorum consists of 10% of the membership.
- 3) Elections will be conducted in the following order: President-elect, Vice President, Treasurer, Secretary (the officers), Directors At Large, and APMA Delegates. There will be no nominations from the floor.
- 4) For those board positions in which multiple nominees are to be elected (e.g., Director at Large) and there are more nominees than open positions, the nominees receiving the most votes cast, up to the number of open positions, will be elected. Voting Members are not required to cast a vote for each vacant position, but may vote only one for each nominee; in other words, if eight nominees are to be elected, all eight of the member's votes may not be cast for one nominee. In addition, voting members may not vote for more nominees than there are open positions. Actions on a ballot not permitted by the rules will spoil the ballot.
- 5) No write-in candidates are permitted.
- 6) If there is a contested position, the presiding officer will announce the election results.

BYLAWS CHANGES UP FOR VOTE

First Proposed Change:

Article IV Membership Meetings Section 6. Mail or Electronic Vote

Voting by mail transmitted by the postal service or electronically shall be permitted in lieu of a vote at a duly called meeting for any item of business, including but not limited to the election of officers and directors. A mail or electronic vote may be called (i) by the Board of Directors; or (ii) upon written request to the Secretary of at least two-third (2/3) of the entire voting membership. However, a A mail or electronic vote for the election of officers and directors automatically shall be conducted in the event that the election cannot occur at the Association's annual meeting of Voting Members because there is less than a quorum present at the meeting or in the event of an extenuating circumstances preventing the annual meeting on an annual basis. The act of a plurality of ten percent (10%) or more voting members returning ballots by a state certain shall be required for the election of officers and directors. For matters other than the election of officers and directors, the act of the members, unless the action of a greater number is required by law, the Articles of Incorporation, or these bylaws.

Second Proposed Change:

Article VI Section 9 - Strike and remove "to serve for the remainder of the unexpired term."

The way it stands now, we have (1) position that renews every 3 years and the other term elections are for multiple positions. This upcoming year, we will have an opportunity to correct that because we had a resignation. By removing the provision that they only serve for the remainder of the unexpired term, it will allow for a more fair election and reelection - leaving the # of positions variable at any given election.

Article VI section 9

In the event of the death, resignation, removal, or incapacity of a director at large, the Board of Directors may appoint an individual to fill the vacancy for the remainder of the term. In the event of the death, resignation, removal, or capacity of an APMA Delegate and subject to the terms of Article IX, Section 2(d)(ii) below, the Board of Directors shall appoint an alternate delegate to assume any delegate duties until the next annual meeting of the members, at which time a delegate will be elected by the members to serve for the remainder of the unexpired term.

Third Proposed Change:

President Elect assumes the roll of Nominating Committee Chair, this change will take away any conflict as the President Elect position automatically ascends to the position of President, is not voted on during the elections.

Article VII Section 6:

The President-Elect shall perform such duties as may be assigned from time to time by the President or the Board of Directors. The President-Elect shall serve as the Chair of the Continuing Education Committee. The President-Elect shall serve as the Chair of the Nominating Committee. The President-Elect shall serve on the Board of the Illinois Foot Health Education Foundation. The President-Elect shall serve as an Alternate APMA Delegate (as defined in Article IX). The President-Elect shall assume the duties of the President in the absence of the President and shall succeed to the office of President in the event of the death, resignation, removal, or incapacity of the President. In the event of the resignation, removal, incapacity or vacancy of the President-Elect, an Acting President-Elect may be appointed by the President with approval of the Board. The office of President fur the following year must be voted on at the next Annual Meeting.

Article VII Section 7:

The Vice President shall perform such duties as may be assigned from time to time by the President or the Board of Directors. The Vice President shall serve as an Alternate delegate (as defined in Article IX) to the APMA House of Delegates. The Vice President shall serve on the Board of the Illinois Foot Health Education Foundation as its Secretary/Treasurer. The Vice President shall serve as the Chair of the Nominating Committee and shall assume the duties of the President-Elect in the absence of the President-Elect in the event of the death, resignation, removal, incapacity, or vacancy of the President-Elect.
